E-Service

As part of an e-service, a person may, on-line, transfer ownership of a home animal to another natural person and confirm the transfer of ownership.

If the owner is dead, the e-service is not available.

Ownership in the case of a deceased owner may be changed if there is a certificate of inheritance. Fill in Form 30 - "Report sheet on a registered household (room) animal", indicating the change of owner or, in the event of the death of the owner of the animal, a person who undertakes to become a holder of a registered household (room) animal for a period of time when the owner (natural person) is unable to fulfil the duties of the owner of the animal or – the owner (natural person) in case, until the approval of the right of succession, a submission regarding the change of the keeper of the house (room) animal and the place of holding shall be submitted to the data centre. '

Process description

Logon service

The customer must apply for a selected service on the Latvija.lv portal or register an event on site IN VPVKAC, taking the Identity Document and the Animal Passport.

Attention!

1. In order to carry out a change of ownership on site, the animal must have written approval from the previous owner of the animal.
2. If the owner is dead, the e-service is not available.
3. Ownership in the case of a deceased animal owner may be changed if there is a certificate of inheritance. Fill in Form 30 — "Report sheet on registered household (room) animal", indicating the change of owner.
4. In the event of the death of the owner of an animal - a person who commits to become a holder of a registered home

(room) animal for a period of time until the owner (natural person) is unable to fulfil the duties of the owner of the animal or, in the event of the death of the owner (natural person), shall submit to the data centre a submission regarding the identity of the keeper of the house (room) animal and the holding change of place. Acquaintance with a list of available

Recipients of services displays two lists:

- registered ownership of domestic (pet) animals;
- domestic (pet) animals which are expected to be transferred to the ownership is a good indication that person.
